1. Photos of the property - Front, Rear, Street view. Digital pictures are preferred, but traditional are fine. No Polaroids.
2. Rent Roll and leases. Do not use a register that might omit late paying customers. Use a roster of what should have been paid. Include move in dates, lease expiration date (or indicate month-to-month) and list the number of bedrooms and bathrooms.
3. Current Income and Expense Report.
4. Previous two years Income and Expense Statements (skip if included in tax returns).
5. Completed 1003 loan application.
6. Explanation of any derogatory credit or liens.
7. Two years tax returns for company and guarantors.\*
8. Settlement statement if owned less than 2 years.
9. Explanation of intended use for any cash out requested.
10. Land contract details, if a buyout.

\* Guarantor returns are not necessary for stated income loans.
